



PO Terms Attachment A.

FAR/DFARS CLAUSES/PROVISIONS.

- A. The listed FAR and DFARS clauses in this Attachment A are incorporated by reference, and as amended from time to time, and made part of this Order with the same force and effect as though set forth in full text.
- B. Unless text in these clauses clearly reserves rights in the Government only or as otherwise noted, the terms “Contractor” means “Seller,” “Contracting Officer” means “Buyer,” “Contract” means this Order and “Government” means “Buyer or the Government.” However, the words “Government” and “Contracting Officer” do not change when a right, act, authorization or obligation can be granted or performed only by the Government or the Prime Contract contracting officer or duly authorized representative.
- C. Applicable thresholds include Truthful Cost and Pricing Data (referred to as “TCPD,” and formerly known as TINA), Simplified Acquisition Threshold (SAT), and Micro Purchase Threshold as stated within acquisition.gov at the time of the Purchase Order.
- D. Whenever the FAR or DFARS clauses include a requirement for the resolution of disputes between the Parties in accordance with the “Disputes clause,” the dispute shall be disposed of in accordance with the provision entitled “Disputes” in this Order.
- E. In the event there is a FAR/DFAR that is not applicable to the current Purchase Activity, those may be deemed not-applicable to the current Purchase Order and the Seller may take exception to those clauses subject to review and acceptance of Buyer.
